# 1. Introduction

In the summer of 2020 ALASCA school moved to a new school building. This new building features a (small) library facility. Such facilities had not been available to us in our previous situation. We are, therefore, currently still in the process of building up our library, by compiling a collection of resources based on our curriculum and the needs of our students. Our library will be accessible to our students from august 2021 onward. This means that students starting in DP1 will have full access to our library.

We recognize the following goals of our library facilities:

1. to have the library serve as the primary resource for students who are looking for additional information on certain topics related to the courses offered in our school and/or are working on research projects, like the Extended Essay and its Dutch equivalent (PWS);

**2**. to give students options to independently study additional languages and/or improve on their language skills, by offering them resources to do so;

3. to offer members of staff resources to improve the quality of their teaching by including a collection of books on learning, pedagogy, classroom strategies and developmental psychology.

4. to promote the enjoyment of reading and support the development of life-long readers.



# 2. Available resources

As stated above our library facilities are new. Because our library and book collection are relatively small, we have chosen to offer our students access to additional databases and collections, thus expanding the available information resources beyond the scope of what we are able to offer within our school.

### **Book collection**

In recent months the school has invested time, energy and means into building a relatively small, but high quality collection of books. The collection of books in our library currently comprises approximately 800 titles, and it is growing. New books are added on a regular basis.

We expect to start school year 21/22 with a collection of at least 1000 books that fit directly with our curriculum and the needs of our students.

Our book collection currently includes:

- Over 300 titles in literature, including both fiction and non-fiction, supporting language courses in Dutch and English. This part of our collection focuses on classic literary works and is currently already being used by our senior students in our Dutch programme. We also offer reading materials for leisure reading.
- Textbooks, periodicals, magazines and reference guides directly supporting <u>all</u> the IB subjects that our school offers. These resources serve as additional reference materials for students who need more support and different perspectives to study the subject topics.
- Additional books directly relevant to and supporting <u>all</u> the IB courses offered at our school. These books serve to give students additional information on topics discussed in the subjects and inspiration for questions that may lead to their Extended Essay and other research projects.
- A collection of more than 100 additional and general books (and periodicals) on academic topics, such as: natural sciences, social sciences, politics, philosophy, history, economics, etc. These books give students possibilities to expand on their general knowledge and pursue their own (academic) interests.
- Several books on research methods, statistics and academic style conventions to support students in research and writing as well as structuring the Extended Essay and its Dutch equivalent (PWS).
- Approximately 25 books supporting (individual) language acquisition needs of our students. We currently offer course books and reference guides for the following languages: English, Dutch, Spanish, German, Japanese and French. Additional resources for other languages will be acquired at student's requests and as a result of the school's plan to develop learner autonomy in language learning and



plurilingualism (see ALASCA - Preliminary Language Policy).

• Over 75 books on learning, pedagogy, classroom strategies and developmental psychology. These books are specifically aimed at members of staff.

#### **Digital resources**

In addition to the school's own library facilities two external, digital resources are provided to our students:

1. Access to collection of the public library of Amsterdam (OBA)

Our school has an agreement in place with the public library of Amsterdam (Openbare Bibliotheek Amsterdam, or OBA in short).<sup>1</sup> All students receive a membership card, allowing them to access the library's collection, read and borrow books and use the facilities of all the libraries in Amsterdam. The OBA offers a wide range of books, e-books and magazines in Dutch, English and the many languages spoken in the Amsterdam community. As part of this agreement, members of staff from the OBA offer workshops to our students on how to use the digital OBA catalogue. All our students, including those enrolled in DP1, follow these workshops.

2. Access to academic databases worldwide (EBSCO)

The school has a licence agreement with EBSCO. As of August of 2021 students in our senior years, including students enrolled in the DP, will have access to a large collection of academic journals and research databases, through the EBSCO portal.<sup>2</sup> This will allow students to access contemporary research that is relevant to the courses offered at school and to the various research projects they undertake, such as the Extended Essay. The librarian and members of the EBSCO support team will offer yearly workshops to senior students on working with the EBSCO portal and databases.

3. Access to digital catalogue Aura Online

Students can find any book in the digital catalogue Aura (<u>https://alasca.auralibrary.nl</u>). The catalogue shows whether a book is available in our library or in the public library. The homepage of Aura offers options to add tiles with links to other useful websites. In this way Aura functions as a portal to other information.

#### Student access to resources

Our book collection is catalogued digitally and students have access to the catalogue by means of <u>https://alasca.auralibrary.nl/</u> and the <u>www.readingcloud.net</u> sitelink in the EBSCO host portal. Students are free to use the books for their studies in the library. It is also possible for students to borrow books from the library. For this purpose the librarian and/or a member

of the support staff is present in the library on two weekly moments: Tuesday afternoon and Thursday afternoon.

All students can access the OBA (public library) and EBSCO databases online from their own devices, and borrow printed resources at one of the public libraries nearby. A desktop computer is present in the library which can be used also to access the databases.

# **3. Other functions of the library**

Our library offers students access to resources for information. We also aim to offer students support in consulting those resources, extracting useful information from them, assessing the validity of that information and using it in relevant and acceptable ways. The library plays a pivotal role in acquiring these skills.

### Supporting research and academic honesty

All IB students follow an interdisciplinary course on research methods in DP1. An important part of the process of conducting research is the gathering, evaluating and using of information. The librarian and EE coordinator support students in this, by collaboratively offering a yearly workshop for DP students on academic integrity and working with the APA style conventions for citing and referring to sources used. To this purpose, an abbreviated version of the APA style guide is distributed digitally to all students each year.

The library also includes several books on research methodology, statistics and academic conventions (APA). These serve as reference materials for students to use when conducting research and/or writing their assignments and essays.

The core ideas of our academic integrity policy is also displayed on a poster that is present in the library and several other places in our school building.

#### Promoting reading and literacy

Every student reads books for their language courses. The library supports language teachers to promote reading and help students find the books they will enjoy reading. The library staff will ask students and teachers to recommend their favorite books to other students. On a regular basis different books are put on visual displays, both online and offline. Books are also promoted by posters and lists with popular books among the students. Two times a year, the library staff will organise activities around the promotion of reading.



# 4. The role of the librarian

The librarian is part of the teaching staff and as such (s)he plays a vital role in supporting the development of the ALASCA Learner Profile and Approaches to Learning. These attributes and skills are installed and reinforced in collaboration with other members of the teaching staff, during dedicated lesson time and additional workshops.

Furthermore, the role of the librarian includes four specific responsibilities:

1. Ensuring that our library, understood as our collection of resources available to students, continues to fit our general goals as outlined in the introduction to this document, i.e. ensuring students have access to the resources needed to complete their courses, conduct their research projects and the Extended Essay. Supporting students in the (self-supported) learning of new languages and other skills they wish to acquire.

This means that the librarian monitors the quality, size and accessibility of the collection, as well as students' needs and wishes with regards to the books available to them;

2. Ensuring students are skilled in searching and finding information and judging its usefulness and validity, specifically concerning the Extended Essay. To this aim the librarian organizes and/or gives several workshops on: working with the public library (OBA) and EBSCO databases, academic honesty and working with the APA style conventions for citation and referencing;

3. Functioning as a source of expertise and inspiration for students (and members of staff) who have any questions about finding, accessing and using (relevant) information through our own library or any other resources;

4. The Librarian plays an important role as Librarian supervisor (Hoang & Taylor, 65), in particular, when it comes to supervision of the Extended Essay (or its Dutch equivalent; the PWS). In this role the librarian supports students aiding their development of skills:

- to access suitable and appropriate resources to conduct the necessary research for the essay.
- to apply research methodologies
- to cite and reference all resources.
